

I began my Primary Education at the all Saints Primary School, Rumukwurushi, upon establishment of the State Primary School Okporo, I continued and completed my Primary School Education at the State Primary School, Aluu in Ikwerre Local Government of Rivers State.

My Secondary Education took me to Comprehensive High School Taabaa, in the Khana Local Government Area of Rivers State and rounded off in the year 1984. I sat for the West African Examination Council (WAEC) / Senior School Certificate (SSE) in 1991. In 1993, I got admission to study Law at the Rivers State University of Science and Technology, Port Harcourt, now Rivers State University which I completed in the year 2003, with LLB (Hons). And holder of Post Graduate Diploma (PGD) in Petroleum and Environmental Law. In 2018 I proceed for a Master Degree Programme and graduated in 2019. 
#### MY LEADERSHIP ROLE

#### **SERVICE TO THE BAR:**

PUBLICITY SECRETARY: During my tenure in 2010-2012, I printed banners that will notify the members of the Branch of the monthly meetings, of which two of the banners were placed at the Rivers State High Court in Port Harcourt, one at the front gate and the second at back gate and another at the main gate of Isiokpo High Court premises, this increased members attendance during monthly meetings.



SECRETARY: My position as the Secretary of the Bar in 2012 -2014 waś a big task. I came into the office without any file handed over to me because there was none. I was faced with the challenge of establishing administrative secretariat for the Branch. I developed a membership register, printed file with the Branch name and logo, opened files for all correspondences such as Minutes File, Committee File, National Correspondence File, Judicial File, Petition File, Action File, others Re-Addressed File, Invitations, Congratulations, Law Firms, Welfare File, Isiikpo Branch Account file, incoming Mails and Outing Mails Development File, Membership Files, Young Lawyers Forum File, Bar Practicing Fees File. This practice has come to stay in Isiokpo Branch.

#### **CHAIRMAN 2014 - 2016**

In 2014, I was elected the chairman of Isiokpo Branch. During my tenure as the Chairman of the Branch, the courts in Rivers State were shut down for over one year. My colleagues and I from other branches made several moves to appeal to the authority concerned to see how the courts can be reopened, but to no avail. The expenses of the National Executive Council (NEC) meetings held from the day I was elected Secretary was done from my pocket, all these did not deter me. During my tenure, I made sure that all unfinished projects were completed. For instance, the Canteen/Restaurant was completed, the Chairman and Secretary's Office, meeting hall, the toilets for ladies and gents. Furniture and fans were provided in the meeting hall, dilapidated ceiling sheets were replaced, and electricity supply to the building was restored and meetings were held in the hall. Again during the period under review. I registered twenty young Lawyers of the Branch to Owerri and Abuja conferences in 2014 and 2015, provided them with accommodation and transportation. I held a Dinner tagged "Kings and Queens" for the first time ever in Isiokpo Branch.

It was during my tenure that my Branch participated in the NBA football competition, in Owerri and Abuja, provided Identity Cards (ID Card) for members and registered Branch members with PAL Pension wherein 80% of their welfare levy is paid into their pension account as savings for their retirement from practice.

The branch account was in red when I took over, but I left over millions of Naira in the branch

coffer.
