ENROLMENT OF COURT ORDER

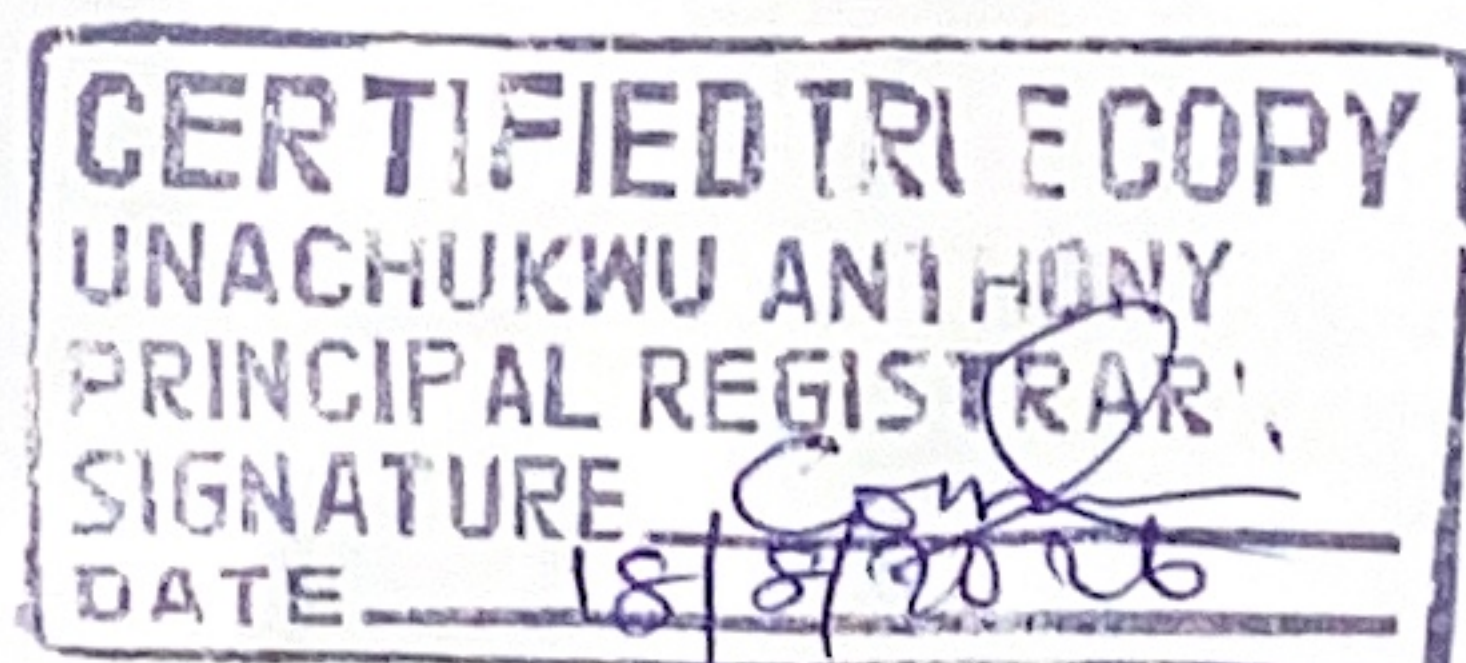

1. **AN ORDER OF INTERLOCUTORY INJUNCTION** restraining the 1st and 2nd Defendants/Respondents, whether by themselves, their servants, agents, privies, assigns or any person(s) acting on their behalf or under their authority, from entering upon, encroaching on, trespassing upon, taking possession of, exercising any rights over, or otherwise interfering with the Claimant/Applicant's possessory and proprietary interests in any part or portion of the land known as Plot No. 1, Giri District, Abuja, vested in the Claimant/Applicant via a letter of Allocation dated January 18, 1989 pending the hearing and determination of the substantive suit.

2. **AN ORDER OF INTERLOCUTORY INJUNCTION** restraining the 1st and 2nd Defendants/Respondents, whether by themselves, their servants, agents, privies, or any persons acting on their behalf or under their authority, from carrying out, authorising, permitting, or continuing any construction, development, demolition, excavation, site clearing, or any other physical activity whatsoever on Plot No. 1, Giri District, Abuja, pending the hearing and determination of the substantive suit.

3. **AN ORDER OF INTERLOCUTORY INJUNCTION** restraining the 1st and 2nd Defendants/Respondents, whether by themselves, their servants, agents, privies, assigns or any person(s) acting on their behalf or under their authority, from allocating, assigning, transferring, granting, creating, recognising or otherwise dealing with or creating any legal or equitable interest whatsoever in favour of any third party over Plot No. 1, Giri District, Abuja, pending the hearing and determination of the substantive suit.

4. **AN ORDER OF INTERLOCUTORY INJUNCTION** restraining the 1st and 2nd Defendants/Respondents, whether by themselves, their servants, agents, privies or any

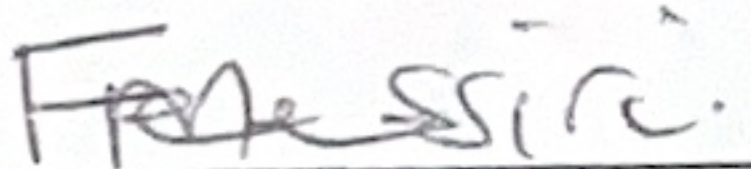


person(s) acting on their behalf or under their authority, from granting consent to, processing, registering or giving effect to any assignment, transfer, sublease, mortgage, charge or any other instrument affecting the title to Plot No. 1, Giri District, Abuja, pending the hearing and determination of the substantive suit.

5. **AN ORDER** of this Honourable Court directing all parties to maintain the status quo ante bellum in respect of Plot No. 1, Giri District, Abuja, pending the hearing and determination of the substantive suit.

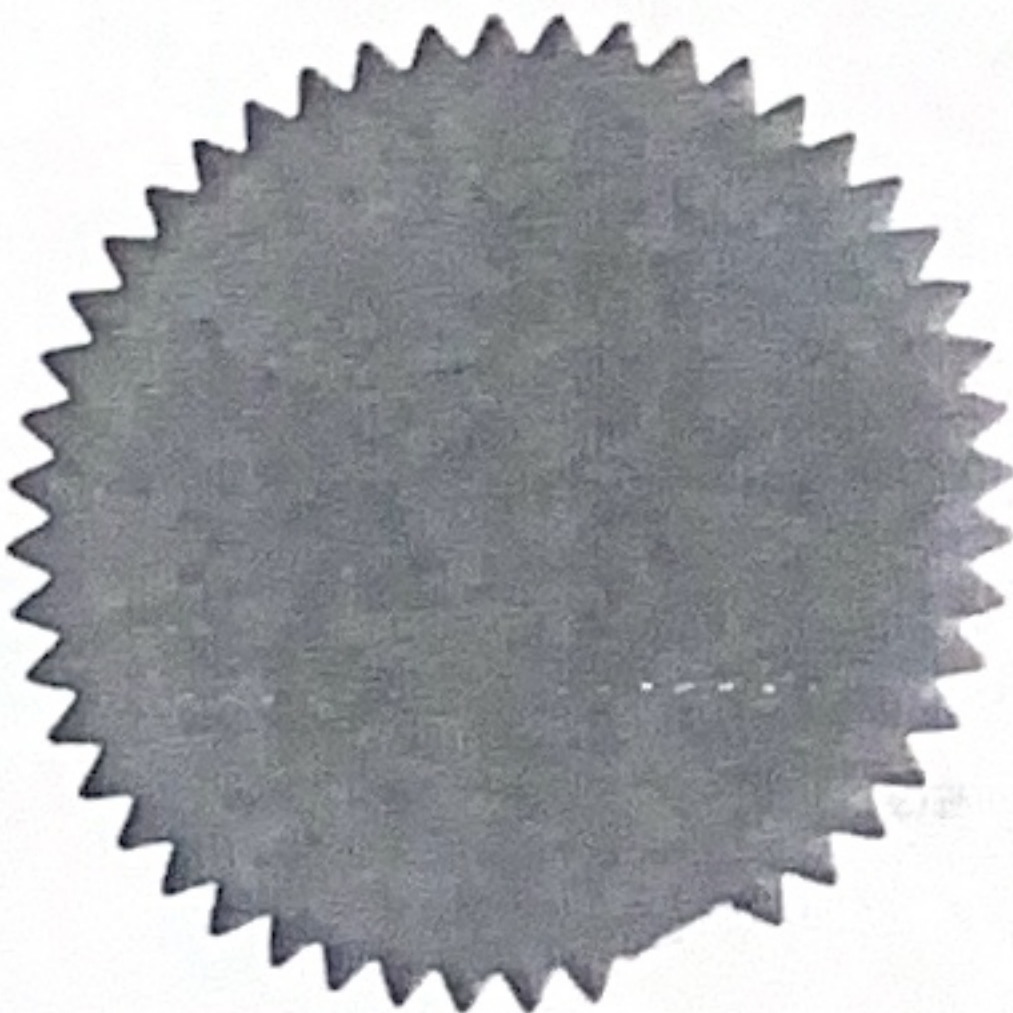
6. **AND FOR SUCH FURTHER ORDER OR ORDER(s)** that this Honourable court may deem fit to make in the circumstance of this case.
